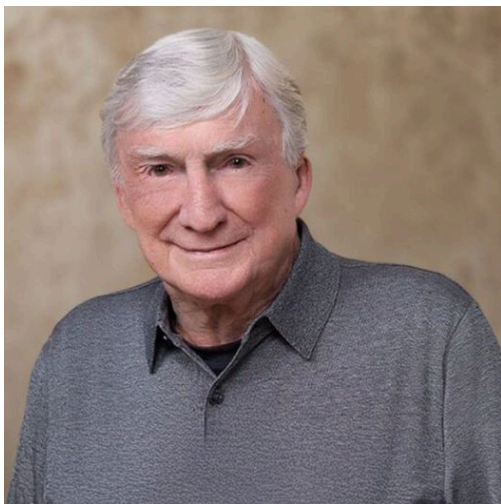

For claims of tortious interference with at-will contracts, plaintiffs now must plead facts showing the defendant's conduct was itself illegal, apart from the "interference." For claims that certain non-compete contracts between businesses violate Business and Professions Code Section 16600, plaintiffs must plead facts suggesting the contracts were anticompetitive under the "rule of reason" standard.
