Such relief, cited by the *Daily Journal*, included barring defendants from any conduct related to the infringement, such as blocking all distribution channels, eCommerce access, shipping channels, financial-institution access, as well as asset freeze orders, which have included millions of dollars in frozen assets at the very inception of a case.

When he represents plaintiffs, Ryan believes in marshalling a case with powerful evidence before filing suit, so the case hits the ground running, making broad early injunctive relief possible, as well as very early summary judgment motions. And when Ryan represents defendants, he embeds himself in the company's ethos and gets to know their employees, so he is able to personalize the company to judges and juries. Ryan takes cases he believes in to his core—regardless of whether he's on the plaintiff or defense side—fighting tirelessly for clients with an unpredictable approach to litigation. "I like to think not just outside the box, I like to use tactics from another dimension," Ryan told the *Daily Journal*.
