Antitrust

In recent federal class action antitrust litigation, Oliver led trial operations and the coordination of a multi-firm team for a large healthcare provider, ultimately obtaining a complete defense verdict for our client in a multibillion-dollar case, following a decade of litigation and months of trial. The case involved complex and cutting-edge antitrust theories, hundreds of witnesses and experts, and extensive confidential information from most major players in the California healthcare and insurance industry. Oliver handled expansive and intense sealing issues related to both documents and depositions, both in pretrial motions and discovery, as well as in the design and implementation of a novel pandemic set-up for the hybrid trial proceedings and testimony.

Oliver also has helped many clients successfully navigate informal investigation and third-party discovery demands in national and state high-risk and high visibility antitrust litigation. He has helped to lead industry joint defense groups and common interest efforts, maintaining the trust and respect of his peers, government investigators, and opposing counsel. He has also presented frequently with investigators, opposing counsel, and the bench on antitrust and related complex litigation matters.

Healthcare Litigation

In addition to work on antitrust matters, Oliver also serves as counsel to healthcare providers and systems throughout California, assisting in successful arbitrations, litigation, and trials concerning contracting practices, employment and whistleblower complaints, privacy and data breaches, and billing and contract disputes. He has obtained numerous favorable decisions and settlements for clients in these matters, against both insurers and government entities.

Franchisor Liability and Defense

Oliver represents national franchisors in California courts. In a recent matter, Oliver led the local counsel team that coordinated and successfully managed dozens of California state court actions by individual plaintiffs, resolving and/or trying matters while coordinating and collaborating with national counsel, insurance counsel, and counsel for individual franchises. His familiarity with courts, judges, and procedures across the state, and management and organization lead to successful resolution and protection of his clients' brand.

Class Actions

Oliver has represented clients in the IT, medical device, pharmaceutical, news, and healthcare industries in both state and federal court class actions, as well as in similar JPML or JCCP coordinated proceedings. His work for these clients in all phases of the proceedings – discovery, pretrial motions, trial representation, and settlement negotiations – has resulted in numerous successful dispositive rulings and favorable settlements.

Commercial Litigation

Oliver serves as counsel for domestic and international technology, life sciences, healthcare, financial services, food & wine, design, e-commerce, retail, and energy companies in complex litigation and business disputes. He has successfully litigated issues involving sales contracts, contractor and employment agreements, stock option grants, fraud, tort and tortuous interference, licensing and marketing contracts, pricing and accounting disputes, non-disclosure agreements, tax matters, and importation and antitrust issues in state and federal courts. He also guides clients to effectively mitigate risk pre- and post-litigation and provides strategic guidance on compliance with federal and state regulations – including privacy, data security and e-discovery regimes – writs of attachment, claims for equitable and injunctive relief, and California's Unfair Business Practices Code (§ 17200).

At a recent trial in Santa Clara County Superior Court, following successful cross-examinations of key plaintiff witnesses, Oliver argued Motion for Judgment that resulted in complete defense victory at close of plaintiff's case. The four-and-a-half year, highly contentious contract and tort litigation concerned allegations regarding the sale of defendant's products throughout Asia, and the company's acquisition of a Swedish software company. The case involved supervising and coordinating electronic files, witnesses, and other work with offices in Colorado, Sweden, Idaho, Malaysia, Hong Kong, Singapore, Seoul, and California.

Oliver negotiated settlement for a major accounting firm in a civil suit related to offshore tax strategies, following IRS litigation with a plaintiff who had engaged the firm's services. He also resolved individual and class claims brought in California courts against a reporting agency concerning personal credit reports and vendor double reporting.

Mass Tort & Life Sciences

Oliver represents leading pharmaceutical manufacturers in product liability, off-label marketing, and pricing disputes brought in state and federal courts. He has removed, litigated, and resolved mass claims related to statins, diabetes, anti-psychotic, and acid-reflux drugs, obtaining early dismissal or settlement in most cases.

Oliver also coordinates MDL and JCCP proceedings for large-scale litigation and has managed related removal proceedings and dockets for local distributors and medical device manufacturers. Throughout, he preserves patient privacy and confidentiality in the litigation process, including compliance with HIPAA and related regulations. He has overseen settlement and dismissal of

resolved cases in concurrent state and federal courts, including management of MSP and MMSEA issues, and related claims administration.

Oliver was lead counsel in California and Idaho medical board reviews of licensed medical and mental health professionals, based upon services provided to inmates in Idaho and California state prisons. He obtained an opinion reversal by opposing counsel's lead expert following deposition and initial review of expert reports in the case. He also provided deposition and trial testimony counsel to state hospital employees in civil and criminal lawsuits.

Oliver is a regular presenter and participant in industry-wide pharmaceutical and medical device conferences.

Toxic Tort & Environmental

Oliver successfully opposed a Notice of Violation under California Proposition 65 for a leading global petrochemical company and negotiated withdrawal of the Notice without the need for formal litigation. He also serves as counsel for chemical manufacturers in cases involving claims by private and public entities related to alleged groundwater contamination, for petrochemical companies in cases involving airborne emissions, and for high-tech companies in EPA superfund actions. In this work, he has successfully brought motions to disqualify experts, dismiss claims and limit damages based upon deposition testimony and IMEs.

Oliver manages litigation for a variety of fortune 1000 companies in product liability and premises claims stemming from alleged exposure to legacy asbestos-containing products, including negotiation of early dismissal, successful filing for summary judgment, and preparation for and successful litigation of cases at trial.

Intellectual Property

Oliver represents leading high-technology, electronics, and life-science corporations in patent infringement, trade secret, and design patent, trade dress, and trademark litigation before U.S. District Courts, the Federal Circuit, I.T.C., U.S.P.T.O., and various international bodies.
